## **Getting Started**

#### **About the Service Portal**

Your property management company has provided a self-service, web interface known as a Service Portal. This interface allows you to enter and track the status of your <u>Service Requests</u> (e.g. requests for repairs in your suite, or to report issues in other areas of the building). In addition, your Service Portal may include <u>Resource Reservations</u> and <u>Visitor Security</u>.

Your property management company will provide a web address, user name and password for using your Service Portal.

Please note that the images included here are for instructional purposes only; depending on how your Service Portal has been configured, and the specific device you are using to access the Service Portal (such as a cellular phone, tablet, laptop or desktop computer), the interface may not appear exactly as depicted.



#### Logging In



If your account's contact information includes an email address, you can use the **Forgot your username or password** link to recover your login information, as shown in the image below the **Sign In** button. After logging in, users who are inactive for 60 minutes will be automatically logged out.

- 1. Open a web browser and enter the web address to your Service Portal, as provided by your Property Management company. The Login screen is displayed.
- 2. Click the **Username** field and enter your user name.
- 3. Click the **Password** field and enter your password.
- 4. If you would like the site to remember your username and password, place a checkmark beside **Remember Me**.
- 5. Click Sign In.

### The Home Page



Depending on how your Service Portal has been configured, as well as your level of access, some features described below may not be available, or their exact positioning or appearance on the page may be different than shown below.

A variety of features and functions can be made available on the Service Portal's home page, which is displayed by default after logging in. A description of each numbered section can be found below.



- Navigation Menu: click the menu button (= MENU) to open the Navigation Menu and access the various features available in your Service Portal. Depending on how your Service Portal has been configured, as well as your level of access, some features described below may not be available, or their exact positioning in the menu may be different.
  - At higher screen resolutions (such as a high-resolution tablet, or desktop computer with a full-screen browser window) the menu will stay open as you navigate between screens unless you click the close button (X MENU).

• At lower screen resolutions where the menu overlaps with other elements on the screen, the menu will automatically close after a selection is made.



The following options are available in the menu. Please note that depending on the services enabled in your Service Portal and your level of access, some options shown above may not be displayed.

- Home: displays this page.
- **To Authorize:** if are a tenant authorizer, click this option to view a list of items <u>awaiting</u> <u>authorization</u>.
- Authorize Settings: if you are a tenant authorizer, use this option to set up <u>automatic</u> <u>authorization</u> for specific request types.
- Service Requests: view the status of your <u>Service Requests</u>.
- New Service Request: create a new <u>Service Request</u>
- Reservations: review the status of your reservations (such as meeting rooms) in a <u>calendar</u> or as a <u>list</u>. Depending on your level of access, you may also be able to see reservations created by your colleagues.
- New Reservation: reserve one of your building's amenities.
- Visits: review a list of visitors that have been entered into the Visitor Security system. Depending on your level of access, you may also be able to see visitors entered by your colleagues.

- **New Visit:** Enter a <u>new visit</u> to keep Property Management informed about your visitors, allowing security to check them in smoothly and efficiently.
- **My Colleagues:** manage your <u>colleague's user settings</u>. This option is only available if you are a Tenant Administrator.
- **New Colleague:** Create <u>new user accounts</u> for your colleagues. This option is only available if you are a Tenant Administrator.
- 2. **User Menu:** this section displays your name. Clicking on your name opens a menu that provides the following options:



- **My Profile**: view and edit your user settings. See <u>Changing Your Profile</u> for additional information.
- Log Out: log out of the Service Portal.
- 3. **Quick Links:** depending on the services available in your Service Portal, up to three quick link buttons are displayed here, allowing you to quickly access the following features without using the Navigation Menu:
  - New Service Request: enter a new Service Request.
  - **New Reservation:** create a new Resource Reservation, such as a meeting room, freight elevator, or other building amenity.
  - New Visit: enter the details for an expected visitor to your building.
- 4. Resource Center: the Resource Center card displays a collection of documents that your property manager has made available to tenants, such as Certificate of Insurance (COI) Compliance and Tenant Handbooks outlining general policies and procedures. Click on a document name to view it.
- 5. Announcements: from time to time, your property management office may issue announcements concerning building-related events or other important information. These announcements may require an immediate action or response than notices that appear in the Property Events card (described below). You can click on the links to display the full details of the announcement.
- 6. **Property Events:** this card displays scheduled property events that may span multiple days, such as construction activities that temporarily restrict building access. Clicking on an event listed here will display additional details.

7. **Billing Reports:** The billing reports card provides links to view monthly summaries of billable tenant requests. These reports are generally available as both PDF and Microsoft Excel files (in some cases they may only be available in PDF format). Tenant Administrators can grant access to this feature to coworkers; see <u>Modifying Colleagues</u> for more information.

Contacts who can access all properties in a tenant group can use a drop-down list to select which tenant's billing reports to display.

8. **Site Feedback:** if you encounter a problem while using the Service Portal, such as a feature or function that does not seem to be working correctly, you can report the issue here.

## **Tenant Service Requests**

#### **The Service Requests List**

The Service Requests list allows you to view and search for service requests that have been made. A history section on each request's details screen tracks status updates to them as they occur. To access the list, click **Service Requests** in the navigation bar to the left.



By default, the system displays requests submitted in the last 30 days, of any request type and status. An overview of the list and its functions are provided below.

- 1. You can sort the list by clicking on the column headings (Request Number, Requested By, Date Submitted, Status, and Request Type).
  - If Property Management uses the Service Rating feature, an additional **Ratings** column shows ratings for completed work orders. For additional information on how the Service Rating system works, please see the <u>Service Rating</u> topic.
- 2. Click on a request number or double-click on the row to view a Service Request's details.

- If the Cancel Service Request feature has been enabled, you can cancel requests in specific circumstances. See the <u>Cancel Service Request</u> topic for details.
- You can add a note to Property Management concerning the service request from the Details Screen. See <u>Sending a Note</u> for additional information.
- Click the **Print** icon () to print a copy of the Service Request's details.
- Click Return to go back to the previous screen you were viewing.

3. Some service request types may have fees associated with them, collectively referred to as billable services. If the Estimates feature has been enabled by Property Management, a cost-estimate can be requested from Property Management when entering a Service Request. Once the estimate is received, it can then be rejected or approved from the Request Details screen; rejected estimates will cancel the Service Request.

Requests with estimates associated with them indicate the status of these requests using color coded icons:

• • • indicates that an estimate request has been sent and is **awaiting a response** from Property Management.

- (E) means that an estimate has been provided by Property Management and is **pending approval** (you can respond by approving or rejecting the estimate).
- (E) denotes that the estimate was **approved**.

For additional details using estimates, see <u>About Estimates</u> and associated topics.

4. Clicking the **Search** icon (Q) displays additional options for filtering the list, as detailed below.

The following filtering options are available:

- **Date:** you can change the date range by clicking on the date fields and selecting a new start and end date.
- **Request Type:** use the dropdown list to select a specific request type (e.g. Elevator, Electrical, Key & Lock, etc).
- **Status:** you can view requests with any status (default), Open, In Progress, Delayed, Declined, Canceled, and Completed.
- **Requested By:** if you have permission to view requests made by your colleagues, you can select a specific colleague with this dropdown list.

- **Request #:** If you know the request number, you can view it by entering the number here.
- **Details:** you can enter key words to search for requests that contain these words in their **Details** field.
- **Property:** if your company has offices in multiple properties, you can select the property using this dropdown.
- **Building:** if your company has offices in multiple buildings, you can select the building using this dropdown.
- Floor
- Suite

Click **Search** to apply your filter options.

5. You can also click the **Print** icon ( ) to print the details of each Service Request that is currently displayed.

#### Making a Service Request



If you need to cancel a request and the <u>Cancel Service Request</u> feature is enabled, then under specific circumstances a service request can be canceled using the Service Portal. For additional details, see the <u>Cancel Service Request</u> topic.

Requests are submitted to report issues that require attention from your Property Management Company. To create a new request, Click **New Service Request** from the navigation menu (= MDW), or click the **New Service Request** quick link from the Home page. This will open the New Service Request screen.



From the New Service Request page, follow the steps outlined below to submit a new request.

- 1. If you have offices in more than one building and your tenancy has been set up to allow you to create requests for more than one property or building, the following additional fields may need to be filled in:
  - If your tenancy spans multiple properties, then the **Property** field will be displayed as a dropdown list. Select the property for the service request.
  - If your tenancy is in more than one building on the same property, then the **Building** field will be displayed as a dropdown list. Select the building for the service request.
- 2. Use the Floor and Suite drop-down lists to select a floor and suite.
- 3. Click the **Request Type** field and select a request type from the drop-down menu.
- 4. If your Property Management Company uses priority levels for requests (as shown above), use the **Priority** drop-down menu to select a priority.
- 5. Your Property Management Company may also require additional custom fields to be filled in. Enter the appropriate information in any additional fields which may be present.
- 6. Provide additional information concerning the request in the Details field .
- 7. Depending on your how your service portal is configured, an **Estimate Required** checkbox may be displayed. Indicate if a cost-estimate is required using the checkbox provided.
- 8. If there are any files you would like to attach to the request, such as pictures, PDFs, or other documentation which concerns the request, click the **Attachments** button and select the file you would like to attach.
  - You can attach a maximum of 3 files.
  - The combined size of all files attached cannot exceed 10MB.
  - After submitting your request, you cannot add, remove, or otherwise modify the attachments.
- 9. Click **Submit**. Your request is submitted and the Request Confirmation screen is displayed.



If your property uses the Authorization feature, your request may require authorization before it can be processed. The system will display a message informing you that authorization is required.

#### **Cancel Service Request**

If this feature is not enabled and you would like to cancel a request, you can request a cancellation by contacting your Property Management office.

If enabled by Property Management, the Cancel Service Request feature allows tenants to cancel service requests under specific circumstances:

- The service request is open and work has not yet started.
- The Service Request belongs to you.
- If <u>Tenant Authorization</u> is used, the service request has already been authorized by a Tenant Authorizer.

If the above criteria are met, then you can cancel the service request by following the steps below:

1. From the <u>Service Requests</u> list, locate the service request you wish to cancel. Click on the **Request Number** or double-click on the row to view its details.

#### Sending a Note

You can append a note to a service request after it has been made. This can be used to provide additional information concerning the request. To send a note, follow these steps:

- 1. Using the <u>Service Requests</u> list, locate the service request you would like to add a note to. Click the request number to display the request details.
- 2. On the request details page, click **New Note**.

#### **Service Rating**

Service Rating is an optional feature that may be enabled by your Property Management company. The Service Rating system allows tenants to rate the overall quality of service received on Service Requests that have been completed. If enabled, you will be able to rate completed Service Requests using either a 2-point (satisfied/unsatisfied) or 5-point (1-5 stars) scale. Which scale is made available to you is determined by Property Management.

If the Service Rating feature has been enabled, you will see an additional **Ratings** column in your Service Requests list.

- If you are using the 5-star rating system, unrated service requests are marked with 5 gray stars in the Ratings column (shown above, left).
- If you are using the satisfaction rating system (**Satisfied** or **Unsatisfied**), unrated service requests are marked with **Rate Service** in the Ratings column (shown above, right).

Once one of your Service Requests has been marked as Completed, you will be able to rate the service provided using one of the two methods described below.

#### In the Service Portal

Completed Service Requests can be rated by viewing the request's details by following the steps below:

- 1. From the <u>Service Requests list</u>, Service Requests that have been completed and are available for rating are indicated in the **Ratings** column, as shown below.
- 2. To view the request's details, click on the Request Number or double-click on the row.

- 3. At the top of the Service Request Details screen is the Service Rating section. Rate the quality of service you received (you will either see a clickable 5-star rating system or **satisfied/unsatisfied** buttons).
  - If you would also like to leave a detailed comment, use the displayed text field on the right to provide additional feedback.
  - When you are finished, click **Submit**. Once you have pressed the **Submit** button, your rating will continue to be displayed at the top of the details screen, but cannot be edited.
  - If your service request is reopened and then closed again (for example, in cases where additional work needed to be done), you will only be able to re-rate the service via <u>e-mail</u> notifications.

#### By Email

If your Service Portal account is subscribed to **Request Completed** notifications, then these emails will include a link to rate the quality of service you have received. For information on checking and updating your subscription settings, see <u>Changing Your Profile</u>.

1. In the Request Completed email notification, click the **Rate Our Service** link. This will open a page in your web browser.



- On the web page that opens, rate the quality of service you received (either 1-5 stars, or Satisfied/Unsatisfied). If you would also like to leave a detailed comment, click Leave a Comment to display a text field that will allow you to provide additional feedback.
  - When you are finished, click **Submit**. Once you have pressed the **Submit** button, the link in the original email will instead direct you to a notice indicating that your feedback has already been received.
  - If your service request is reopened and then closed again (for example, in cases where additional work needed to be done), you will receive a new email message, allowing you to re-rate the service provided.



## **Resource Reservations**

#### **About Resource Reservations**

Resource Reservations allows tenants to reserve resources such as a conference rooms, freight elevators, and loading docks.

#### **Key features**

- Use a Calendar interface to submit new reservations and view upcoming ones.
- Receive e-mail confirmations when your reservation is created, approved, or rejected.
- Track the status of your reservation, especially in cases where approval of your reservation is required by property management.
- Cancel or reschedule reservations you had previously submitted. Canceled or rescheduled reservations many incur a service charge. Please review your Property Manager's policies to determine if this will be the case.
- If made available by Property Management, reserve resources in other nearby properties.

#### The Reservations Calendar

The My Reservations calendar allows you to view and search through reservations that have been made by your or your colleagues, such as for service elevators and meeting rooms. To access the calendar, click on **Reservations** from the navigation menu.



By default, the calendar displays reservations submitted in the current month. An overview of the calendar and its functions is provided below.



1. Depending on your level of access and the way resources have been set up by property management, the following dropdown menus may be available:

- If Property Management has made resources from other properties available to you, you can use the **Property** dropdown list to view reservations submitted in specific properties, or select **Any Property** (default) to see all reservations across all properties.
- If you are able to view your colleagues' reservations, you can use the **Requested By** dropdown list to filter the calendar by colleague, or select **Any Requested By** (default) to see all reservations. If you do not have access to view your colleagues' reservations, only your own reservations are displayed.
- 2. The **Previous** (**■**) and **Next** (**▶**) buttons are used to page between months, weeks, or days, depending on the calendar's view mode as described in (4) below. The **Today** button will return you to the current month, week or day, as applicable.
- 3. The calendar displays submitted reservations and their current status.
  - Confirmed reservations are marked in green.
  - Reservations that require approval from Property Management are marked in yellow.
  - Reservations marked in red are either canceled reservations, or reservations that were not approved by Property Management.
  - If more than two reservations fall within a particular day (in monthly view mode), clicking the **More** button (...) will change the calendar to a daily view, allowing you to see all reservations made in the current day.
  - Clicking on a reservation will take you to the reservation's Details screen. See <u>The</u> <u>Reservation Details Screen</u> for additional information.
- 4. The **Month**, **Week** and **Day** buttons allow you to toggle the calendar between a monthly, weekly and daily view.
- 5. Use the **List** button ((i)) to view reservations in a list format. See the <u>The Reservations List</u> topic for additional details.
- 6. The **Print** button (b) will print reservations for the currently displayed reservations in a list format.

#### The Reservations List

The Reservations list allows you to view and search through reservations that have been made by you or your colleagues, such as for service elevators and meeting rooms. To access the list, click **Reservations** in the navigation menu, then click the **List** button (E) at the top of the calendar interface.



By default, the calendar displays reservations submitted in the current month. An overview of the list and its functions are provided below.

  - Any applicable reservation policies, such as maximum reservation duration, or conditions under which a rescheduling or cancellation fee may apply. Please note that rescheduling and cancellation fees are not related to whether the resource is listed as "billable", which refers to fees that may be incurred through use of the resource.

#### The Reservation Details Screen

The Reservation Details screen is accessed by clicking on a reservation in the <u>Reservation Calendar</u> or <u>Reservation List</u>. The following information and buttons are displayed:



- 1. The reservation ID number.
- If enabled by Property Management, you can click Cancel Reservation to cancel the reservation (you can only cancel upcoming reservations). See <u>Canceling a Reservation</u> for more information.
- 3. Click **Return** to go back to either the Reservations List or Reservations Calendar.
- 4. If the resource being reserved requires additional documentation to be downloaded, filled in/signed and then re-uploaded to finalize the reservation, this will be clearly marked at the top of the reservation screen. If all documentation has been uploaded, then the **Requires Approval** icon is highlighted, as shown above. Reservations that do not require uploading documents do not display these icons.
- 5. If a reservation is still pending approval by property management, then a **Requires Approval** message is displayed. If documentation needs to be uploaded, this section also provides an interface to download the documents that must be filled out, and a means of uploading the completed documents.
  - If a document has already been uploaded but needs to be replaced, click the **Replace** button (as shown above). Documents that have not yet been uploaded will instead display an **Upload** button.
  - Documents can be downloaded, uploaded or replaced at any time by returning to the details screen. It is not necessary to perform this task during a single log-in session.
- 6. The Reservation Details section displays the following information:
  - The resource(s) requested.
  - The name of the requestor.
  - The reservation date and time.
  - The duration and location where the reservation will take place.
  - The responses given to any additional questions that were asked during the reservation process. If these responses need to be changed, contact your Property Management office.
  - All included amenities and selected optional amenities. If any selections made here need to be changes, contact your Property Management office.
  - Any notes for Property Management that you have added to the request; see (9) below.
- 7. The History section displays a record of status changes related to the request, with the date and time of each status change displayed.
- 8. Click **Reschedule** to change the date and time of the reservation. See <u>Rescheduling a</u> <u>Reservation</u> for additional details.
- In the Reservation Notes section, you can update any existing notes you have entered by clicking the Edit button (shown above). If no notes were originally provided, you can create notes by clicking the Add button.

### **Canceling a Reservation**

Reservations can be canceled from either the <u>Reservations Calendar</u> or the <u>Reservations List</u> by viewing a reservation's details and clicking **Cancel Reservation**. Please note that depending on your level of access, you may only be able to cancel reservations made in your name. # **Meeting Room Panel**

### **About Meeting Room Panel**

Meeting Room Panel is a touchscreen solution that allows tenants to browse room availability and create, change, or cancel a reservation right at the meeting room door.



If this feature is available in your building, refer to the additional topics in this section. Other topics that may be useful are <u>Changing Your Profile</u> and (for Tenant Administrators) <u>Modifying Colleagues</u>, both of which contain information on how to send or re-send the login information needed to use Meeting Room Panels.

#### The Meeting Room Panel Interface (Reservation Mode)



This topic only applies to panels that are in **reservation mode**. For a feature overview of a panel that is in **display mode**, see <u>The Meeting Room Panel Interface (Display Mode)</u>.

An overview of the Meeting Room Panel's functions and options are detailed below.



- 1. This area indicates the current status of the meeting room: Available, Reserved, In Progress, or Unavailable.
  - Available means the room is immediately available for use (if a reservation is made).
  - **Reserved** indicates that the room is currently reserved, but the meeting has not been started.
  - In Progress means the room is currently reserved and the meeting is in progress.
  - **Unavailable** indicates that the room is not in use or reserved, but is unavailable for a reservation at this time.
- 2. Tapping the info icon (II) displays information about the resource that may include: A description, available amenities (included, or available on request), and a photo gallery.
  - Any amenities listed will indicate if they are **Included** or **Available on Request**. Amenities that will incur a service charge are marked as **Billable** (S).
  - If more than one image is provided, you can switch between pictures by tapping the Previous ( < ) and Next ( > ) arrows, located to either side of the currently displayed image.



- 3. Depending on how the meeting room is configured and the current status of the meeting room, the following options may be displayed in this area:
  - Start Early: Allows your to start your meeting early if the room is currently not in use. Depending on how the room's availability has been configured, this option may not be available. See <u>Starting a</u> <u>Meeting Early</u> for additional details.
  - **Start Meeting:** This button appears at the appointed start time for your meeting. Tap this option to start your meeting. See <u>Starting a Meeting</u> for additional details.
  - End Meeting: This option appears 15 minutes after a meeting has started. Tap this button to end your meeting. See Ending a Meeting for additional details.
  - Extend Meeting: If there are no reservations after your meeting end-time, this option will appear, allowing you to extend the duration of your meeting. Depending on how the room's availability has been configured, this option may not be available. See Extending a Meeting for additional details.
- 4. To check the availability of the room or make reservations on another day, you can tap on the Previous ( < ) and Next ( > ) arrows located to either side of the date. You can skip ahead to a specific day by tapping on the date, which will display a calendar interface, allowing you to change the displayed month and day (as shown below).

Times that have already reserved are displayed with the name of the company that has made the reservation (unless the individual that reserved it has made it anonymous). Available blocks of time are displayed in between those times and are labeled **Tap to reserve**. # Visitor Security

### **The Visitor Security List**

Through the Visitor Security list you can view and search through visits that have been entered, update their details, and enter new visits. To access the list, click on **Visits** in the navigation menu ( $\equiv$ <sup>MOW</sup>).



An overview of the visitor security list and its functions are detailed below.



- 1. By default, the list is sorted by Expected Date. You can sort the list in ascending or descending order by clicking on the following headings:
  - Expected Date
  - Host
  - Floor



It is important to note that the individual who created the visit (Entered By) may be different from the Host.

- You can view a visit's details by clicking on the expected date, or by double-clicking on the row. You can also edit or cancel a visit while viewing a visit's details. See <u>The Visit Details Screen</u> topic for additional information.
  - If the visitors will be issued single use badges, then the visit will be marked with a single use badge icon next to the date and time (A). Single use badges are automatically disabled after the first time they are used at a security scanner.
  - If the visitors will be issued badges that have had the **allow entry until** feature enabled, then the arrival time is replaced with a time range that indicates the range of time that the the security badges will be active for.
- 3. You can review any notes attached to the visit by clicking the **Note** icon (). Notes are also displayed and can be edited from the <u>Visit Details</u> screen.
- 4. The list is configured to displayed visits within a specified date range. By default, visits are displayed for the next month (30 days). You can use the quick links to conveniently switch between **Today**, **7 days**, and **30 days**. The most recently selected quick link is remembered between login sessions. Additional date and filtering options are also accessible from the **Search** button (Q) as described in (6) below.
- Click Import From Excel to upload visits from a list that you have created. This list must be saved as a Microsoft Excel Spreadsheet (XLS) file. You can download a template for the list from within the Import Visitors interface, as described in Importing a Visitor List.
- 6. Click the **Search** button (Q) to view additional filtering options, as detailed below.

# **Entering a New Visit**

Visitor Security enables you to pre-register your visitors using the Service Portal. This feature ensures visitors are quickly processed and promotes building security.

To enter a visitor into the system, click **New Visit** from the navigation menu ( $\equiv$  www), or click the **New Visit** quick link from the Home page. This will open the New Service Request screen.



There are two methods for manually entering a visit's details: Form Entry (default), and Quick Entry. You can also import a visitor list from an excel spreadsheet. If you have a list of names that you would like to copy and paste, click the **Quick Entry** link. This will change the **Visitors** section of the interface to a unified field where you can paste the visitor's name, company and email address in a single line. For additional details, see Entering a Visit with Quick Entry.

Follow the steps below to enter a new visit:



 The Visitors section of the Visit details screen is used to enter information about the people who are expected to arrive. There are two methods for manually entering a visit's details: Form Entry (default), and Quick Entry. You can switch between these modes by clicking on the Quick Entry/Form Entry button in the top-right corner. If you would prefer to import a list of visitors from an Excel spreadsheet, you can instead select Import From Excel.

## Self Check-In

#### Introduction to Self Check-In

Visitor Self Check-In is a system that allows visitors to use a self-serve kiosk in order to check-in and print a badge. If this system is available in your building, visitors entered with email addresses will be sent PINs in advance of their visits, which are required to use the Self Check-In kiosks.

For more information, see Self Check-In Email Notifications, and Using Self Check-In.

#### Self Check-In Email Notifications

For buildings that have Self Check-In enabled, whenever a visit is entered into the system that includes the visitor's email address, a notification email is sent which includes the name of the company being visited, and a 6-digit PIN. A sample notification email is shown below.

- Visitors that are entered on the same day as the visit will receive their PIN within 5 minutes of being submitted.

#### **Using Self Check-In**

At the main screen, pressing Check In starts the process.



Visitors are able to check in using the kiosk in 3 easy steps:

- 1. Locate the company being visited.
  - The visitor can filter the list by letter (for example, displaying all companies that start with "C"). Once found, the visitor selects the company.
  - The **Previous** and **Next** buttons at the bottom of the screen can be used to page through longer company lists.

# Package Pass

## **About Package Pass**

In properties where removal of goods is a concern, Package Pass allows tenants to identify individuals who will be removing specific items from the building, and provide authorisation to building security allowing the item to be removed.

Package Pass provides the following features:

- Names a specific person who will be removing items from an office.
- A physical description of the items being removed can be provided.
- Package Pass requests require approval from a Tenant Authorizer.
- Once approved, a pass can be printed.

See the additional topics in this section for additional information on using Package Pass.

## The Package Pass List

The Package Pass List is a searchable list of all package pass requests, whether they are still awaiting approval, have been approved or declined. To open the Package Pass list, click on **Package Passes** in the navigation menu (= MINN).



An overview of the Package Pass list and its functionality is detailed below.

## **Estimates**

### **About Estimates**

Some service request types may have fees associated with them, collectively referred to as **billable services**. If the Estimates feature has been enabled by Property Management, a cost-estimate can be requested from Property Management when entering a Service Request. Once the estimate is received, it can then be rejected or approved; rejected estimates will cancel the Service Request.

The estimate request and approval process varies depending on whether you have <u>Tenant Authorization</u> enabled or not:

- Estimates with tenant authorization
- Estimates without tenant authorization

#### With Tenant Authorization

When Tenant Authorization is enabled, only Tenant Authorizers can request, approve or reject estimates. Requests for estimates must occur before approving the item.

#### **Requesting an Estimate**

- 1. When <u>authorizing items</u>, any billable service request will provide Tenant Authorizers with the option to request an estimate. Select **Request Estimate**.
- 2. Click Save My Decision.

Tenant Administrators are users that have access to your Service Portal and have the ability to grant colleagues permission to do one or more of the following:

- Make tenant requests
- View billing reports
- Request reservations
- Create visits
- Self-subscribe to announcements

The abilities that a Tenant Administrator has are determined by their Tenant Administrator Permissions, which are set up at the time the account is created (or can be added later by Property Management).
#### Adding a Colleague

To add a colleague as a contact in the Service Portal, click **New Colleague** from the Navigation Menu ( MENU). The Contact Entry screen is displayed.
